**SECTION 1. APPROPRIATION.** The amount of Thirty-Four Thousand Eight Hundred Pesos (P34,800.00) sourced from the funds stated in the Statement of Funding Sources (LBP Form No.8), form an integral part of this ordinance is hereby appropriated as Supplemental Budget No.20 as stated to cover the;
