MUNICIPAL ORDINANCE NO. 87 S, 2020

AN ORDINANCE APPROPRIATING THE AMOUNT OF FIVE HUNDRED SIXTY-FOUR THOUSAND THREE HUNDRED EIGHTY-ONE PESOS AND 35/100 (P564,381.35) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM NO.8), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO.23 AS AND FOR THE PURCHASE OF MEDICINES ,SUPPLIES AND VITAMINS FOR NUTRITIONALLY AT-RISK CHILDREN AGED 0-71 MONTHS OLD AND REPRODUCTION OF MODULES FOR CHILD DEVELOPMENT SERVICE FOR S.Y. 2020-2021 UNDER MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN AS STATED IN THE LBP FORM NO.09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

SECTION 1. APPROPRIATION. The Amount of Five Hundred Sixty-Four Thousand Three Hundred Eighty-One Pesos and 35/100 (P564,381.35) sourced from the funds stated in the Statement of Funding Sources (LBP Form No.8), form an integral part of this ordinance is hereby appropriated as Supplemental Budget No. 23 as stated to cover the following;

SECTION 2. PURPOSE. The Amount of Five Hundred Sixty-Four Thousand Three Hundred Eighty-One Pesos and 35/100 (P564,381.35) is intended for the various projects, programs, and activities under Municipal Council for the Protection of Children in the Municipal Department of Social Services and Human Protection.

SECTION 3. DISBURSEMENT. The disbursement of the foregoing fund shall be the responsibility of the Local Chief Executive (LCE) to comply with the existing provisions on accounting/ auditing rules and regulations of the provision of R.A 7160 and other issuances governing the same in the disbursement of funds.

SECTION 4. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.




