AN ORDINANCE APPROPRIATING THE AMOUNT OF THIRTY-SEVEN THOUSAND FOUR HUNDRED NINE PESOS AND 25/100 (P37,409.25) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM NO.8), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO. 24 AS AND FOR THE PROVISION OF MEDICINES AND VITAMINS FOR SENIOR CITIZENS AND DIFFERENTLY-ABLED PERSONS AS STATED IN THE LBP FORM NO. 09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.

**BE IT ENACTED,** by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

**SECTION 1. APPROPRIATION.** The Amount of Thirty-Seven Thousand Four Hundred Nine Pesos and 25/100 (₱37,409.25) sourced from the funds stated in the Statement of Funding Sources (LBP Form No. 8), form an integral part of this ordinance is hereby appropriated as Supplemental Budget No. 24 as stated to cover the;

 Provision of medicines and vitamins supplies for Senior Citizens And Differently-Abled Persons

**SECTION 2. PURPOSE.** The Amount of Thirty-Seven Thousand Four Hundred Nine Pesos and 25/100 (\$\mathbb{P}\$37,409.25) is intended for the provision of medicines and vitamins supplies for Senior Citizens and Differently-Abled Persons.

**SECTION 4. EFFECTIVITY.** This ordinance shall take effect immediately upon its approval.
