**BE IT ENACTED**, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

**SECTION 1. APPROPRIATION.** The amount of Six Hundred Thousand Pesos (P600,000.00) sourced from the funds stated in the Statement of Funding Sources (LBP Form No.8), form an integral part of this ordinance is hereby appropriated as Supplemental Budget No.28 as stated to cover the;

 In the Municipal Department of Engineering and Public Works

**SECTION 2. PURPOSE.** The amount of Six Hundred Thousand Pesos (P600,000.00) is intended for the Ground Improvement of Slaughter House (Concrete Pavement) in the Municipal Department of Engineering and Public Works;

DISBURSEMENT.** The disbursement of the foregoing fund shall be the responsibility of the Local Chief Executive (LCE) to comply with the existing provisions on accounting/ auditing rules and regulations of the provision of R.A 7160 and other issuances governing the same in the disbursement of funds;

**SECTION 4. EFFECTIVITY.** This ordinance shall take effect immediately upon its approval.




