WHEREAS, Local Budget Circular No. 103 dated 15 may 2013 states that, an Officer-In-Charge (OIC) position authorized in the Local Government Unit (LGU) staffing pattern is entitled to Representation Allowance and Travelling Allowance (RATA);

WHEREAS, Article 56 of Municipal Ordinance No. 103 series of 2020 states that, when an officer or employee is designated to a position that requires concurrence by the Sangguniang Bayan in the event of a regular appointment, such officer or employee shall not be entitled to any representation and transportation allowance unless his/her designation as officer-in-charge is similarly concurred by the Sangguniang Bayan. The effectivity of his/her entitlement shall retroact to the date of his designation;




