No. 7160 and Local Budget Memorandum No. 80 dated 18 May 2020 issued by the Department of Budget and Management;

**WHEREAS**, the Sangguniang Bayan of San Roque, Northern Samar, after final evaluation, finds the herein Barangay Resolution valid and operative;

**NOW, THEREFORE**, upon motion of SB Member Ethel O. Ramirez, unanimously seconded by all the Sangguniang Bayan Members present, **be it..**

**RESOLVES**, as it is hereby **RESOLVED**, to declare the Barangay Resolution No. 20-024, Series of 2020 The Annual Investment Plan (AIP) for Calendar Year 2021 of Barangay Bantayan, San Roque, Northern Samar amounting to Five Million Seven Hundred Fifty-One Thousand Seven Hundred Eighty-One Pesos (P5,751,781.00). **Provided**, that the disbursement of the appropriations as approved, shall be subject to the existing accounting and auditing rules and regulations. And the programs, projects, and activities (PPA) to be undertaken shall strictly be subject to the provision of R.A. 9184 (Government Procurement Reform Act.).

**RESOLVED FURTHER**, that the copies of this resolution shall be furnished to the Office of the Punong Barangay, Office of the Sangguniang Barangay both of Barangay Bantayan, San Roque, Northern Samar, Other Offices Concerned and Office File for their information and guidance.


