WHEREAS, as mandated by Republic Act No.7160, otherwise known as the Local Government Code of 1991, and other pertinent DILG Circulars, provided that the every Local Government Unit is mandated to prepare and submit Annual Investment Plan (AIP) to the Department of Interior and Local Government (DILG) and other concerned agencies, for the preparation of its Annual Budget;

WHEREAS, the Annual Investment Plan (AIP) Calendar Year 2020 of the Municipality of San Roque, Northern Samar includes the different programs and projects per sector and sub-sector, the work activities and financial plan for the 20% Development Plan, 5% GAD, 5% DRRM, 1% Senior Citizen, 1% MCPC, Inter-Agency Aids, Statutory and Contractual Obligations, Personnel Services, MOOE, Capital Outlay and other funds from other sources of agencies;

WHEREAS, the Municipal Government fully supports and promotes the general welfare of the people by providing programs, projects, and which will help in the efficient delivery of basic services to its constituents;

WHEREAS, President Rodrigo R. Duterte, through Presidential Proclamation No.929, series of 2020 dated March 11, 2020, declared the entire country under State of Calamity due to rapid increase of cases of infection of Covid-19 throughout the entire world and enjoining all Government Agencies and Local Government Units (LGUs) to render full assistance and cooperation and mobilize all necessary resources to undertake critical, urgent, and appropriate response and measures in a timely manner to curtail and eliminate the threat of Covid-19;

WHEREAS, the Municipal Development Council (MDC) and the Municipal Disaster Risk Reduction and Management Council (MDRRMC), in its emergency meeting held on March 16, 2020, have arrived with a consensus decision to utilize any existing available fund necessary to response to the mandate of national government and came up to augment fund for the following indentified programs, projects, and activities significant for Covid-19 protection programs, to wit:
