A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ATTY. DON L ABALON, MNSA, TO ACCEPT THE DEED OF DONATION FOR AND IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF SAN ROQUE, NORTHERN SAMAR FROM RENE LAGRIMAS CANTONG, ET. AL ADMINISTERED BY THE DONOR DANILO CANTONG OCHONDRA, A PARCEL OF LAND TO BE USED EXCLUSIVELY FOR THE CONSTRUCTION OF FOOTBRIDGE ALONG GENAGDANAN RIVER IN BARANGAY GENAGDANAN, SAN ROQUE, NORTHERN SAMAR.

WHEREAS, Section 22 paragraph C of Republic Act (RA) No. 7160 otherwise known as the Local Government Code of 1991 provides that, no contract may be entered into by the Local Chief Executive (LCE) for and in behalf of the Local Government Unit (LGU) without prior authorization by the Sangguniang Bayan concerned;

WHEREAS, the donor, Danilo C. Ochondra is the registered administrator of a parcel of land identified as Lot No. 3077 Card 683-D located at Barangay Genagdanan, San Roque, Northern Samar;

WHEREAS, in compliance with the provisions under Presidential Decree (PD) No. 957, the herein donor hereby transfers and conveys in favor of the DONEE, the Local Government Unit of San Roque, Northern Samar a parcel of land containing an area of 250 square meters more or less; covered by OCT No. 1260 located at Barangay Genagdanan, San Roque, Northern Samar covered by the Road Right of Way intended for the construction of footbridge project;

WHEREAS, the donor, Danilo C. Ochondra hereby transfers and conveys by way of **DONATION**, unto the said Donee a parcel of land of the above-described real estate property with all the rights, interest and title of the said parcel of land, free from all liens and encumbrances;

RESOLVES as it is hereby **RESOLVED**, To Authorize the Municipal Mayor Atty. Don L Abalon, MNSA, to Accept the Deed of Donation For and In Behalf of the Local Government Unit of San Roque, Northern Samar from Rene Lagrimas Cantong, et. al, Administered by the Donor, Danilo Cantong Ochondra, A Parcel of Land to be Used Exclusively for the Construction of Footbridge along Genagdanan River in Barangay Genagdanan, San Roque, Northern Samar.
