WHEREAS, Section 22 paragraph C of Republic Act (RA) No. 7160 otherwise known as the Local Government Code of 1991 provides that, no contract may be entered into by the Local Chief Executive (LCE) for and in behalf of the Local Government Unit (LGU) without prior authorization by the Sangguniang Bayan concerned:

WHEREAS, Mr. Maximo M. Resuello Jr. is the absolute owner of a portion of lot designated as Road Lot, covered by Katibayan ng Orihinal na Titulo Blg. 23516;

WHEREAS, in compliance with the provisions under Presidential Decree (PD) No. 957, the herein donor hereby cedes, transfers and conveys in favor of the Local Government Unit of San Roque, Northern Samar a parcel of land containing an area of 1,609 square meters more or less; covered by ORIHINAL NA TITULO BLG. P-23516;

WHEREAS, the donor, Mr. Maximo M. Resuello Jr. hereby transfers and conveys by way of **DONATION INTER VIVOS**, unto the said Donee, the real property above-described, with all the rights and interest existing thereon, free and clear of all liens and encumbrances;
