WHEREAS, Local Budget Circular No. 103 dated 15 May 2013 states that, an Officer-In-Charge (OIC) position authorized in the Local Government Unit (LGU) staffing pattern is entitled to Representation Allowance and Travelling Allowance (RATA);

WHEREAS, Article 52 of Municipal Ordinance No. 79, series of 2019 states that, when an officer or employee is designated to a position that requires concurrence by the Sangguniang Bayan in the event of a regular appointment, such officer or employee shall not be entitled to any representation and transportation allowance unless his/her designation as officer-in-charge is similarly concurred by the Sangguniang Bayan. The effectivity of his/her entitlement shall retroact to the date of his designation;

WHEREAS, the disbursement of fund shall be in accordance with the usual government accounting and auditing rules and regulations;

WHEREAS, the August Body took consideration as to the services and performances of the herein designated Officer-In-Charge in the Business Permits and Licensing Office in the Municipality of San Roque, Northern Samar;
