A RESOLUTION DECLARING THE BARANGAY APPROPRIATION ORDINANCE NO.002 SERIES OF 2020 OF BARANGAY COUNCIL OF BARANGAY ZONE-2, POBLACION, SAN ROQUE, NORTHERN SAMAR, APPROPRIATING THE AMOUNT OF FIFTY THOUSAND TWO HUNDRED FORTY-ONE PESOS AND 50/100 (Php50,241.50) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING SOURCES LBP FORM NO.8 AS SUPPLEMENTAL BUDGET AS AND FOR THE MOOE-OMOE (YOUTH ASSISTANCE FOR EMERGENCY AND CALAMITIES) AS STATED IN LBP FORM NO.9 AND MADE INTEGRAL PART THEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES, VALID AND OPERATIVE IN ITS ENTIRETY.

WHEREAS, this August Body, upon the recommendation of the Committee on Budget Finance and Appropriation, acted favorably declaring as valid and operative in its entirety, the Barangay Appropriation Ordinance No.002, series of 2020 of the Barangay Council of Barangay Zone-2, Poblacion, San Roque, Northern Samar, which was embodied in its committee report dated 27 April 2020 and was duly adopted by the body;

WHEREAS, the herein committee finds the said Barangay Appropriation Ordinance No.01, series of 2020, in order and in compliance with the JMC No.01, issued by the DILG & DBM, Presidential Proclamation (PD) No.929 & 922 issued by the President of the Republic of the Philippines and Section 106 of Republic Act (R.A) No.7160;

WHEREAS, that the approval of the said Barangay Appropriation Ordinance is subject to the availability of funds and all accounting and auditing rules, and other existing laws and regulations pertinent thereto.
