WHEREAS, the government's mandate on Universal Health Care (UHC), through the Department of Health's "FOURmula One for Health (F1+for Health", commits to achieve the overall health system goals of improved health outcomes, financial risk protection, and responsiveness under the Health Facilities Enhancement Program (HFEP);

WHEREAS, the Health Facilities Enhancement Program (HFEP) serving as the national government's major strategy to provide assistance to government-owned healthcare facilities for improvement of infrastructure, equipment upgrades, medical transport such as mobile dental vans and ambulances, and acquisition of land for health facility expansion. The different project proposals are approved annually and allocated funds under the HFEP;

WHEREAS, Department of Health thru the Health Facilities Enhancement Program (HFEP) for Calendar Year 2020 has appropriated the amount of Two Million Pesos (P2,000,000.00) intended for the Repair/Completion of San Roque RHU to be implemented and procured by the Local Government Unit of San Roque thru transfer of fund;
