A RESOLUTION DECLARING THE BARANGAY APPROPRIATION ORDINANCE NO.01, SERIES OF 2020 OF BARANGAY COUNCIL OF BARANGAY MALOBAGO, SAN ROQUE, NORTHERN SAMAR, APPROPRIATING THE AMOUNT OF THREE HUNDRED TWENTY-SEVEN THOUSAND PESOS (Php327,000.00) SOURCES FROM 20% EDF AND 10% SK FUNDS OF GENERAL FUNDS STATED IN THE STATEMENT OF FUNDINGS SOURCES, IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET FOR THE OTHER NECESSARY COVID-19 RELATED PPAS AND EXPENSES, WELFARE GOODS FOR DISTRIBUTION FOR AFFECTED FAMILIES AND OTHER EXPENSES RELATED TO COVID-19 OUTBREAK, AND MADE INTEGRAL PART THEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES, VALID AND OPERATIVE IN ITS ENTIRETY.
