**WHEREAS**, Section 447 (a)(5)(x) of Republic Act (R.A.) No. 7160 otherwise known as the Local Government Code of 1991, provides that, the Sangguniang Bayan, subject to the availability of funds and to the existing rules and regulations, establish and provide for the operation of vocational and technical schools and similar post-secondary institution and, with the approval of the Department of Education, Culture and Sports, fix and collect reasonable fees and other school charges on said institution subject to existing laws on tuition fees;

**WHEREAS**, the educational system of today's generation should be oriented in order that the population of the Philippines particularly in the Province of Northern Samar, especially the youth could be equipped with skills to become more productive;

**WHEREAS**, a developed educational system in the province of Northern Samar could be best implemented through the establishment of extended campus to nearby municipalities in order to reach as many young people as government resources can afford;

**WHEREAS**, establishment of an EXTENSION CAMPUS of UEP Main in the Municipality of San Roque, Northern Samar, is direly needed since the location of the latter is in midrange between UEP Main Campus and UEP Lao-ang and Catubig campuses, which will be more accessible and reachable to the secondary schools and senior high school graduates of San Roque who desires to pursue and complete a college degree;


**WHEREAS**, the Local Government Unit of San Roque (LGU-San Roque), will provide site/location of the proposed Extension Campus of UEP Main.


