WHEREAS, the formulation of the Local Anti-Criminality Action Plan (LACAP) of every unit of the PNP is embodied in the LOI 18/2019 "Eastern Visayas Integrated Peace and Order and Strategic Plan", the PNP Integrated Transformation Program, and the NHQ PNP LOI 71/08 (PAYAPA);

WHEREAS, the Municipal Peace and Order Council (MPOC) of San Roque, Northern Samar, the Armed Forces of the Philippines, and the concerned Civil Society Organizations, shall implement a responsive anti-criminality strategy to effectively prevent, control, and suppress the occurrence of all forms of criminal activities in the municipality;

WHEREAS, the Municipal Peace and Order Council (MPOC) of San Roque, Northern Samar, through MPOC Resolution No. 01, series of 2020, hereby endorsed the LACAP for adoption of the Sangguniang Bayan;




