**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR DON L. ABALON TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (For the Lotto & Small Town Lottery Shares from the Charity Fund and Calamity Assistance), AND FOR OTHER PURPOSES.**

**WHEREAS**, the PCSO is the principal government agency mandated to raise and provide funds for health programs, medical assistance and services, and charities of national character, through the conduct of sweepstakes, races, nationwide online lottery ("Lotto"), Small Town Lottery ("STL") and other similar activities;

**WHEREAS**, the thrust of the administration of President Rodrigo Roa Duterte are to ensure the provision and availability of medical facilities for emergency services, health care programs and social services, and provide appropriate forms of assistance to areas and persons affected by calamities and disasters;

**WHEREAS**, the PCSO recognizes the role of LGUs as PCSOs partners in raising revenues within their jurisdiction and in turn would like to support LGUs in providing the need in medical and health services to their constituents;


**WHEREAS**, the PCSO pursuant to its mandate and aligned with the President's programs, provides LGUs with a portion of the charity fund generated from the sales of Lotto and STL within their jurisdiction, as share for LGUs to be used by them for their medical and health-related services.


**NOW, THEREFORE**, upon motion of SB Member Ethel O. Ramirez, duly seconded by SB Member Alvin M. Lagrimas, be it...

**RESOLVES**, as it is hereby **RESOLVED**, to authorize the Municipal Mayor, Don L. Abalon to enter into a memorandum of agreement with the Philippine Charity Sweepstakes Office (For the Lotto & Small Town Lottery Shares from the Charity Fund and Calamity Assistance), and for other purposes.


