**WHEREAS**, Proclamation No. 1021 extended the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 declared under Proclamation No. 929, Series of 2020;

**WHEREAS**, Joint Resolution No. 4 approved on June 17, 2009, defines Hazard Pay as premium given to government personnel exposed to hazardous situations such as but not limited to, assignment in strife-torn or embattled areas, distressed or isolated stations, prison camps, mental hospitals, leprosaria, radiation-exposed clinical/laboratories/workshops, disease-infected areas and areas declared under state of calamity or emergency which pose occupational risks or perils to life;

**WHEREAS**, the Local Frontline Public Health Workers composed of regular, contractual or casual positions and Job Orders (JOs) workers in the municipality of San Roque, Northern Samar were rendering 24/7 duty detail and services in the LGU-Quarantine Facility where the Locally Stranded Individuals (LSI) coming from different places received and quarantined for 14 days or more depending on their actual status prior to their completion of quarantine period and release;

**WHEREAS**, the LGU-Quarantine Facility catering Locally Stranded Individuals (LSI) or considered persons under monitoring pose occupational hazard risks to Local Frontline Public Health Workers;

**WHEREAS**, Budget Circular No. 2020-1 dated March 24, 2020 provides for the guidelines on the Grant of COVID-19 Hazard Pay which covers employees in the LGU, either occupying regular, contractual or casual positions or workers engaged through contract of service (COS), job order (JO), or other similar schemes;

**NOW THEREFORE**, upon motion of SB Member Dante C. Tan duly seconded by SB Member Freddie F. Jarito, SB Member Hilario S. Acebuche, SB Member Ethel O. Ramirez, SB Member Solidad S. Cagro, Ex-Officio Member/ABC President Freddie F. Jarito and Ex-Officio Member/PPSK-President Ness Lei S. Lagrimas, **be it...**

**RESOLVES** as it is hereby **RESOLVED**, to request Honorable Mayor Don L. Abalon and the Local Finance Committee, to Allocate Funds for the Grant of Hazard Pay and/or Special Risk Allowance to Local Frontline Public Health Workers of the Municipality of San Roque, Northern Samar Rendering Services during the Period of State of Calamity.






