ROMUALDEZ, THE AMOUNT OF SIXTEEN MILLION PESOS (P16,000,000.00) FOR THE ROAD IMPROVEMENT/CONCRETING OF THE SITIO PATONG TO BARANGAY LAWAAN SECTION OF THE NATIONAL HIGHWAY(BANTAYAN) TO BRGY. GINAGDANAN FARM TO MARKET ROAD IN, SAN ROQUE, NORTHERN SAMAR.

WHEREAS, the development of the National Highway (Brgy. Bantayan) to Barangay Lawaan Road by concreting its remaining unpaved and undeveloped portions along Sitio Patong to Barangay Lawaan with a distance of just about 800 meters out of 12 kilometers will benefit not only the domestic tourism stakeholders but more so the vegetable and upland farmers that would have easy access to market their local produce;




