**WHEREAS**, the Office of the Secretary to the Sangguniang Bayan received measure entitled "The Revenue Code of Barangay Bantayan, San Roque, Northern Samar" and the same was referred to the Committee on Ways and Means and Committee on Good Government, Public Ethics and Accountability which conducted its committee meeting and rendered committee report which was adopted and carried by the August Body;


