WHEREAS, Department of Budget and Management (DBM) issued Local Budget Circular (LBC) No. 128, dated September 17, 2020, prescribing the Guidelines on the Release and Utilization of the Local Government Support Fund (LGSF) COVID 19 Financial Assistance to Local Government Units (LGUs) in the Bayanihan to Recover As One Act, Republic Act No. 11494.

WHEREAS, in under the Bayanihan to Recover As One Act or Republic Act No. 11494, government agencies particularly local government units are mandated to adopt and implement measures to prevent or suppress further transmission and spread of the virus through compulsory and immediate isolation of confirmed, suspected and probable Covid-19 patients;


WHEREAS, for the smooth and effective operation of the municipal government of San Roque, Northern Samar, Local Chief Executive and Sangguniang Bayan Members of this municipality hereby extend financial request for funding assistance for the proposed project: **"COVID-19 Isolation Units"** amounting to P15,000,000.00 from the Local Government Support Fund – Financial Assistance to LGUs under the "Bayanihan to Recover as One Act", Republic Act No. 11494.






