RESOLUTION DECLARING BARANGAY ORDINANCE NO. 03, SERIES OF 2020 THE COMMUNITY FISH LANDING CENTER (CFLC) OR AS "BAGSAKAN CENTER" OF FISH CATCH OF THE MUNICIPAL FISHERFOLKS OF THE MUNICIPALITY OF SAN ROQUE, NORTHERN SAMAR, CONSISTENT WITH LAW AND OTHER MUNICIPAL ORDINANCES..

WHEREAS, Article IV, Section 59 of the Implementing Rules and Regulations of Republic Act 8550 known as the Philippine Fishery Code of 1998, with the Coordination of other concerned agency with the Local Government Unit mandates for the establishment of post-harvest facilities for fishing, such as but not limited to; Municipal Fish Landing Sites, Fish Fort and Cold Storage and other fish processing establishment to serve primarily the needs of Municipal Fisherfolk.;

WHEREAS, Chapter 1, Section 2, of the Fisher Administrative Order No. 78, series of 2015, the main objective of the Community Fish Landing Center serves as "BAGSAKAN CENTER" is to provide better post-harvest handling and processing systems, and faster access to reduce post-harvest losses, providing access to vital services to ensure clean, safe and legitimate fishing practices;

WHEREAS, the function of the Community Fish Landing Center (CFLC) serves as "BAGSAKAN CENTER", are as follows:

- a.) Trading hub for fresh fish catch and processed products;
- b.) Post-harvest handling and processing center;
- c.) Data collection and monitoring of fish catch & stock assessment;
- d.) Information hub for relevant services (such as Registration and Licensing of Fisherfolk, Fishing Vessels, and Hazard Warning;
- e.) Fish Product landed at the CFLC which upon inspection are found to have been caught in violation of Fishery Laws, Fisheries Administrative Order & Fishery Ordinance shall immediately be reported to the nearest Police Outpost or Station for appropriate disposition and filling of charges thereafter.

NOW THEREFORE, upon motion of SB Member Alvin M. Lagrimas, duly seconded by SB Member Solidad S. Cagro, SB Member Ethel O. Ramirez, SB Member Feddie F. Jarito & SB Member Jincky F. Cisneros, be it..




