**WHEREAS**, at present the ambulance of municipality of San Roque, Northern Samar is old enough, under repair and no longer serviceable, hence, the Local Government Unit of San Roque, Northern Samar is compelled to address this problem through the Philippine Charity Sweepstakes Office;

**WHEREAS**, transport of patients to nearby hospital is being done by borrowing patient transport vehicle on nearby municipalities or by hiring private vehicle causing the Municipality financial constraint, especially in transporting patients to hospital outside the province;

**WHEREAS**, the PCSO is the principal government agency mandated to raise and provide funds for health programs, medical assistance and services, and charities of national character, through the conduct of sweepstakes and other similar activities;

**WHEREAS**, in order to complement the critical role of the Local Government Unit of San Roque, Northern Samar in ensuring the delivery of health services to the people and securing the welfare needs of its constituents;

**WHEREAS**, an authority to sign the **DEED OF DONATION** by the Municipal Mayor is a requirement pursuant to R.A 7160, otherwise known as the Local Government Code of 1991;

**NOW THEREFORE**, upon motion of SB Member Jincky F. Cisneros, unanimously seconded by all the Members of the Sangguniang Bayan, **be it...**






