SANGGUNIANG BAYAN RESOLUTION NO. 99 S, 2020

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR DON L ABALON TO ENTER INTO AN AGREEMENT WITH THE UNIVERSITY OF EASTERN PHILIPPINES (UEP) TO SECURE THE SERVICES AND ASSISTANCE OF THE UNIVERSITY FOR THE PREPARATION AND CRAFTING OF PEOPLE'S SURVIVAL FUND PROPOSAL RELATIVE TO PROGRAMS AND PROJECTS FOR CLIMATE CHANGE ADAPTATION RESILIENCY.

WHEREAS, Section 14 of Republic Act (R.A.) No. 9729 states, that the LGUs shall be the frontline agencies in the formulation, planning and implementation of climate change action plans in their respective areas;

WHEREAS, Section 18 of the same Act, as amended by R.A. No. 10174 called People's Survival Fund (PSF). It is a special fund in the National Treasury for the financing of climate change adaptation programs and projects;

WHEREAS, climate change adaptation refers to the ability of a community to cope with the consequences present in the area and strengthen its adaptive capacity;


WHEREAS, the Local Government Unit of San Roque will securing services and assistance of the University of Eastern Philippines to establish the preparation and crafting of PSP Proposal relative to programs and projects for climate change adaptation and resiliency;

NOW, THEREFORE, upon motion of SB Hilario S. Acebuche, unanimously seconded by all the Sangguniang Bayan Members present, **be it...**

RESOLVES, as it is hereby **RESOLVED**, to authorize the Municipal Mayor Don L Abalon to enter into an Agreement with the University of Eastern Philippines (UEP) To Secure the Services and Assistance of the University for the Preparation and Crafting of People's Survival Fund Proposal Relative to Programs and Projects for Climate Change Adaptation Resiliency.




