MUNICIPAL ORDINANCE NO. 71 S, 2023

**AN ORDINANCE RENAMING THE SAN ROQUE DIVERSION ROAD TO CONGRESSMAN
EMIL L. ONG AVENUE**

WHEREAS, Congressman Emil L. Ong has dedicated his life to public service, tirelessly advocating for the welfare and development of the Province of Northern Samar, particularly the Municipality of San Roque, which has attained unprecedented growth and development due to his invaluable contribution;

WHEREAS, throughout his tenure, Congressman Emil L. Ong has made significant contributions to the development and progress of the Municipality of San Roque, enhancing the quality of life for its constituents and residents;

WHEREAS, renaming the San Roque Diversion Road to Congressman Emil L. Ong Avenue is a fitting tribute to honor the late Congressman Emil L. Ong for his outstanding service and commitment to the Province and its people, and for his distinguished public service and significant contributions;

NOW, THEREFORE, upon motion of SB Member Dante C. Tan, duly seconded, the SANGGUNIANG BAYAN, in session assembled, ENACT:

Section 1. The San Roque Diversion Road, currently designated as such, shall henceforth be officially renamed as "Congressman Emil L. Ong Avenue."

Section 2. The renaming shall be effective immediately upon the implementation of this Ordinance.

Section 3. The Municipal Government shall install appropriate signages along the road, reading "Congressman Emil L. Ong Avenue", or its official abbreviation "Cong. Emil L. Ong Ave.", at regular intervals for the convenience of residents, visitors and motorists.

Section 4. The Municipal Government shall notify relevant agencies, including but not limited to the Department of Public Works and Highways, Land Transportation Office, Philippine Postal Corporation, the National Historical Commission of the Philippines, to recognize and update their records accordingly. Appropriate coordination shall be made with the National Historical Commission of the Philippines in compliance with the existing law.

Section 5. If any provision of this ordinance is declared invalid or unconstitutional, the remaining provisions shall remain in full force and effect.

Section 6. All ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.


Section 7. This ordinance shall take effect upon its approval.


