MUNICIPAL ORDINANCE NO. 84 S, 2023

AN ORDINANCE REPEALING MUNICIPAL ORDINANCE NO. 76, SERIES OF 2023, AND FOR OTHER PURPOSES

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that;


Section 1. The Municipal Ordinance No. 76, series of 2023, entitled An Ordinance Enacting the Code of General Ordinances of the Municipality of San Roque, Northern Samar, is hereby repealed.

Section 2. All ordinances, resolutions, orders, rules and regulations that may have been previously repealed, modified or amended with the enactment and approval of Municipal Ordinance No. 76, series of 2023, are hereby reinstated and reenacted, and shall remain in full force and effect until the same may subsequently be repealed, modified or amended as the case may be.


Section 3. The Codification Committee is hereby created pursuant to Memorandum Order No. 01 series of 2023 dated May 26, 2023, of the Municipal Vice Mayor which is composed of the SB Committee Chairman on Public Works and Highways Infrastructure Development and Special Project as chairperson , the SB Committee chairman on Good Government and Public Ethics and Accountability as vice chairperson, and as members the following: the Sangguniang Bayan Members, the Municipal Planning and Development and Coordinator, the Municipal Treasurer, and the head of the Business Processing and Licensing Office. The principal function of the codification committee is to review all existing municipal ordinances, rules and regulations and codify them into one single Code of General Ordinances for submission to the Sangguniang Bayan within a period of one month from the approval of this Ordinance.


Section 4. This Ordinance shall take effect immediately upon its approval.






