MUNICIPAL ORDINANCE NO. 72 S, 2023

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 56, S. 2023, AND FOR OTHER PURPOSES

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

SECTION 1. Section 1 of Municipal Ordinance No. 56 s. 2023, is hereby amended to include the following sentence, to wit:


“Electrification of Government Facilities means Installation of transformers, power lines, and other infrastructures necessary for effective, efficient and reliable delivery of electricity to Government Facilities (Super Health Center, Central MRF, Residual Containment Area, and others).”

SECTION 2. Repealing Clause. All Ordinances, issuances, rules and regulations inconsistent with the provisions of this ordinance are hereby repealed, amended, rescinded and/or modified accordingly.

SECTION 3. Separability Clause. If, for any reason, any provisions, or any part hereof is declared invalid or unconstitutional by a competent court, other provisions hereof not affected thereby, shall remain in full force and effect.

SECTION 4. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.






