**MUNICIPAL ORDINANCE NO. 91 S, 2023**

**AN ORDINANCE AMENDING SECTION 8 OF MUNICIPAL ORDINANCE NO. 31, S. 2022,  
AND FOR OTHER PURPOSES**

**BE IT ENACTED**, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

**SECTION 1.** Section 8 of Municipal Ordinance No. 31 series of 2022, is hereby amended to include the following sentences, to read as follows:

Section 8. Centenarian/Senior Citizens who intends to claim such cash incentive benefit shall be required to present any two (2) of the following documents, to wit;

“a. Voter’s registration certificate as proof of being a voter in the municipality or in any component barangay where he/she resides.”

“b. OSCA ID issued and signed by the Mayor and by the OSCA Head or National ID issued by the PSA.”

“c. Any valid documents that will establish that the awardee is 85-89, 90, 95 and 100 years of age like livebirth, baptismal or marriage certificate.”

“d. If the claimant has no documents to submit for availing such benefit affidavit of two disinterested person will suffice.”

“In all instances, the beneficiary or anyone of his children or grandchildren must be a registered voter in the Municipality of San Roque, Northern Samar.”

**SECTION 2. Repealing Clause.** All Ordinances, issuances, rules and regulations inconsistent with the provisions of this ordinance are hereby repealed, amended, rescinded and/or modified accordingly.

**SECTION 3. Separability Clause.** If, for any reason, any provisions, or any part hereof is declared invalid or unconstitutional by a competent court, other provisions hereof not affected thereby, shall remain in full force and effect.

**SECTION 4. EFFECTIVITY.** This ordinance shall take effect immediately upon its approval.






