MUNICIPAL ORDINANCE NO. 95 S, 2023

AN ORDINANCE CREATING THE PLANTILLA POSITIONS OF ADMINISTRATIVE OFFICER II (BUDGET OFFICER – 1) IN THE MUNICIPAL BUDGET OFFICE AND YOUTH DEVELOPMENT OFFICER I IN THE OFFICE OF THE MUNICIPAL MAYOR/MUNICIPAL YOUTH DEVELOPMENT OFFICE, ABOLISHING THE PLANTILLA POSITION OF (1) LOCAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER II (ITEM NO.1011-9) IN THE OFFICE OF MUNICIPAL MAYOR/MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE, (2) MUNICIPAL GOVERNMENT ASSISTANT DEPARTMENT HEAD 1 (COMMUNITY AFFAIRS OFFICER IV) (ITEM NO.1011-6) IN THE OFFICE OF THE MUNICIPAL MAYOR/BARANGAY AND COMMUNITY AFFAIRS OFFICE, AS AND FOR OTHER PURPOSES.

WHEREAS, Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government units shall design and implement its own organization structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standard and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 447 (a) of the same Code provides that the Sangguniang Bayan has the power to determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employee paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the Municipal Government.

WHEREAS, the positions of (1) Local Disaster Risk Reduction and Management Officer II (Item No.1011-9) in the Office of Municipal Mayor/Municipal Disaster Risk Reduction and Management Office, (2) Municipal Government Assistant Department Head I (Community Affairs Officer IV) (Item No.1011-6 are vacant and the current administration deems it unneeded at the moment; meanwhile, the position of Administrative Officer – II (Budget Officer – I) in the Municipal Budget and Youth Development Officer - I in the Office of the Municipal Mayor/Municipal Youth and Development Office which can be created utilizing the savings from the abolished positions;

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

SECTION 1. The position of Administrative Officer – II (Budget Officer – I) in the Municipal Budget Office and Local Youth Development Officer – 1 in the Office of Municipal Mayor/Municipal Youth Development Office are hereby created.

SECTION 2. The plantilla position of (1) Local Disaster Risk Reduction and Management officer – II (Item No. 1011-9) in the Office of Municipal Mayor/Municipal Disaster Risk reduction and Management Office, (2) Municipal Government Assistant Department Head – I (Community Affairs Officer IV) (Item No.1011-6) are hereby Abolished ;

SECTION 3. The total amount of Ninety – Four Thousand Six Hundred Forty-Six Pesos and 16/100 (Php94,646.16) representing the unexpended appropriation for the salaries and other emolument and personnel benefits of the abolished positions, reverted to the general fund, is hereby re-appropriated to cover the salaries and other emoluments and personnel benefits of the created position;

SECTION 4. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.


