MUNICIPAL ORDINANCE NO. 73 S, 2023

AN ORDINANCE REVERTING TO THE GENERAL FUND THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS ONLY (Php150,000.00) AND RE-APPROPRIATING THE SAME AMOUNT AS AND FOR THE VARIOUS PROJECTS, PROGRAMS AND ACTIVITIES AS STATED IN THE LBP FORM NO.09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

SECTION 1. APPROPRIATION. The Amount of One Hundred Fifty Thousand Pesos Only (P150,000.00) sourced from the funds stated in the statement of funding Sources (LBP Form No.08), form an integral part of this Ordinance is hereby appropriated as Supplemental Budget No.3 as stated to cover the following, to wit:

- 1. Basketball Tournament (In the Office of the Municipal Mayor/Tourism) - P107,000.00
2. Cycling Competition (In the Office of the Municipal Mayor/Tourism) - P43,000.00

SECTION 2. PURPOSE. The amount of One Hundred Fifty Thousand Pesos Only (P150,000.00) is intended for the various projects, program and activities;

SECTION 3. DISBURSEMENT. The disbursement of the foregoing fund shall be the responsibility of the Local Chief Executive (LCE) to comply with the existing provisions on accounting/ auditing rules and regulations of the provision of R.A 7160 and other issuances governing the same in the disbursement of funds;

SECTION 4. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.


