AN ORDINANCE GRANTING FRANCHISE TO MR. JUANITO B. BALUYOT, JR. TO OPERATE A MOTORIZED TRICYCLE WITHIN THE JURISDICTION OF SAN ROQUE, NORTHERN SAMAR

WHEREAS, It is the policy of the state to: a) protect the interest of the tricycle sector by providing them with adequate and timely social, economic and legal services that shall protect their rights and promote benefits to ensure their dignified existence and economic advancement; b) recognize, promote gender equity and equality the rights of every worker in the tricycle sector; c) promote safety and protect the riding public; and d); develop local economy through the potential and contribution of the tricycle sector;

WHEREAS, Pursuant to R.A. No. 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Bayan as a legislative body may regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality subject to the guidelines prescribed by the Department of Transportation and Communications (DOTr now).

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

SECTION 1. A Municipal Franchise is hereby granted to Mr. Juanito B. Baluyot, Jr. for the operation of one (1) unit motorized tricycle along Route 1 from Poblacion - Ginagdanan via Bantayan Vice Versa, and any point of San Roque subject to the following terms and conditions of the Department of Transportation and Communications (DOTR now).

SECTION 2. That the validity of the Municipal Franchise is one (1) year only.

SECTION 3. Effectivity. This ordinances shall take effect upon its approval

DONE and APPROVED, this 11th day of September, 2023 at Sangguniang Bayan Session Hall, 2nd Floor, Balaudnan Building, San Roque, Northern Samar, Philippines.




