**MUNICIPAL ORDINANCE NO. 01 S, 2022**

**AN ORDINANCE GRANTING AUTHORITY TO THE MUNICIPAL MAYOR DON L ABALON TO UTILIZE THE LOT OF THE MUNICIPAL NURSERY FOR THE ESTABLISHMENT-CONSTRUCTION OF THE SUPER RHU FUNDED BY THE DEPARTMENT OF HEALTH**

**WHEREAS**, it is a state policy to protect and promote the right to health of its people;

**WHEREAS**, based on Section 16 of the Local Government Code, every local government unit has the implied power to do all things necessary, appropriate, or incidental to govern efficiently and effectively, promote general welfare, promote health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, strengthening our RHU is important not only to address individual and family health needs, but also addressing broader issues of public health and the needs of defined populations;

**WHEREAS**, the Municipal Government of San Roque, Northern Samar is just fortunate as a recipient of the 2019 DOH-HFEP (Health Facilities Enhancement Program);

**WHEREAS**, there is an urgent need to utilize the lot of the Municipal Nursery for the benefit and interest of the Municipal Government of San Roque, Northern Samar and their inhabitants.

**BE IT ENACTED**, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that;

**Section 1.** The lot owned by the Municipal Government and is currently being used as Municipal Nursery situated along the Diversion Road, Brgy. Zone 1, San Roque, Northern Samar shall henceforth be reserved for use and shall be utilized for the Super RHU which shall be constructed for the 2019 HFEP of the Department of Health.

**Section 2. Granting Authority.** The Municipal Mayor shall have the authority to utilize the lot of the Municipal Nursery for the establishment-construction of the Super RHU funded by the Department of Health under its 2019 DOH-HFEP (Health Facilities Enhancement Program).

**Section 3. Separability Clause.** If for any reason, a part of this Ordinance is declared unconstitutional, ultra vires, inoperative, or otherwise illegal or invalid, other parts or provisions hereof that are not affected thereby shall remain valid and in full force and effect.

**Section 4. Repealing Clause.** All previous ordinances, rules and regulations or parts thereof, in conflict with, or inconsistent with any provisions of this ordinance are hereby repealed or modified accordingly.

**Section 5. Effectivity Clause.** This ordinance shall take effect immediately upon its approval.

**RESOLVED FURTHER**, that a copy of this ordinance be furnished to the offices/agencies concerned.




