**BE IT ENACTED**, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

**SECTION 1.** Municipal Franchise is hereby granted to **Mr. Fausto L. tenedero, Jr.** for the operation of one (1) Unit of tricycle along Route 1 from Poblacion – Ginagdanan via Bantayan Vice Versa. And any point of San Roque, Poblacion subject to the following terms and conditions.

A. Validity of the Franchise is one (1) year.

**SECTION 2.** This Ordinance shall take effect immediately upon its approval.




