**BE IT ENACTED**, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

**SECTION 1.** Municipal Franchise is hereby granted to **Mr. Roldan N. Soriano** for the operation of one (1) Unit of tricycle along Route 2 from Poblacion – Lao-angan via Dale Vice Versa. And any point of San Roque, Poblacion subject to the following terms and conditions.

A. Validity of the Franchise is one (1) year.

**SECTION 2.** This Ordinance shall take effect immediately upon its approval.
