**SECTION 1.** Municipal Franchise is hereby granted to **Mr. Rolly J. Munes** for the operation of one (1) Unit of tricycle along Route 1 from Poblacion – Ginagdanan via Bantayan Vice Versa. And any point of San Roque, Poblacion subject to the following terms and conditions.

A. Validity of the Franchise is one (1) year.
