MUNICIPAL ORDINANCE NO. 31 S, 2022

AN ORDINANCE GRANTING CENTENARY BENEFIT AND OTHER INCENTIVES AND/OR BENEFITS TO SENIOR CITIZENS UNDER CERTAIN CONDITIONS, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES

BE IT ENACTED by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

SECTION 1. There is hereby granted each and every senior citizen who has reached the age of eighty-five an advance centenary benefit, as follows:

- a) For senior citizen who has reached the age of eighty-five years old upon approval of this ordinance, he/she shall be entitled to receive the advance centenary benefit in the amount of One Thousand Pesos (Php1,000.00) each year until he/she reached the age of eighty-nine years of age.
- b) For Senior Citizens who has reached the age of ninety years old, he/she shall be entitled to receive one time advance centenary benefit in the amount of Ten Thousand Pesos (Php10,000.00); and
- c) For Senior Citizen who has reached the age of ninety-five years old shall be entitled to one time advance centenary benefit in the amount of Twenty Thousand Pesos (Php20,000.00).

SECTION 2. A senior citizen who has reached the age of one hundred years old shall continue to receive the full amount of One Hundred Thousand Pesos (Php100,000.00) as centenary benefit as provided for under R.A 10868 and Municipal Ordinance No. 81, series of 2017, without diminution for whatever other benefits he may have receive under this Ordinance.

SECTION 3. Senior citizen who are already more than ninety-five years old shall receive the advance centenary benefit to which one has reached ninety-five of age is entitled under this Ordinance.

SECTION 4. Senior Citizen who are already more than eighty – five years old shall receive their annual advance centenary benefit, and the benefits provided for herein shall not apply retroactively.

SECTION 5. No senior citizen shall be entitled to receive the centenary benefits and the advance centenary benefits unless the following conditions are present, to wit:

- a) Must be registered with the barangay, Municipal Federation and with the Office of Senior Citizens Affairs (OSCA) of the Municipal Government, with the corresponding senior citizen identification card and number.
- b) Must be active, either personally or through a representative, in attending and/or participating in meeting and other activities of the senior citizens group in his barangay and municipal federation.
- c) Must be resident in any of the component barangays of the Municipality of San Roque, Northern Samar. A resident in one who is either a registered voter and/or physically residing in the barangay concerned.

SECTION 6. The disbursement of the foregoing benefits herein is subject to the existing provisions on accounting and auditing rules and regulations.

SECTION 7. Unless specially provided for with the funds in the General Annual Fund Budget, the funds currently appropriated for social and/or social amelioration may be utilized for the granting of the benefits herein so provided. Accordingly, the Municipal Mayor shall allocate from the current appropriations for social services and/or social amelioration so much amount as needed for the benefits herein granted.

SECTION 8. Centenarian/Senior Citizens who intends to claim such cash incentive benefits shall be required to present his/her voters registration certificate as proof of his/her being a voter and identity of age.

SECTION 9. SEPARABILITY CLAUSE. If, for any reason or reasons, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof, which are not affected thereby, shall continue to be in full force and effect.


SECTION 10. REPEALING CLAUSE. All ordinances and rules inconsistent with the provisions of this Ordinance are hereby modified or repealed accordingly.

SECTION 11. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.




